Club Rules

OPENING HOURS

From 8.00am to 8.00pm

Last entry 45 mins before cutting off time.

All club members and guests should be preparing to vacate the facilities 30 mins before closing.

GENERAL

PARQ – You must complete a PARQ (Pre-Activity Readiness Questionnaire) before using any of the club's facilities. Ask at reception for details.

Medical Conditions

If at any time during your membership your medical condition changes you must inform us immediately in writing as it may affect the type and frequency of the exercise/activity which you are able to undertake. Equally, if you feel unwell at any time whilst in the club cease the activity and inform a member of staff.

Clothing & footwear

Suitable and appropriate clothing and footwear must be worn whilst in the club for the activity you are planning to undertake. No outdoor footwear is to be worn on poolside.

Please remove all jewelry which is liable to cause injury or harm due to entrapment.

Changing Rooms

All items are left entirely at the owner's risk. For temporary use only. Any items left overnight will be removed and placed in lost property 30€ fee will be incurred to remove them.

Shaving

The activity of shaving is not permitted.

Lost Property

All items placed in lost property will remain there for 1 week. If unclaimed after this period they will be donated by the club to charity.

Membership Freezing

Provided all fees are paid up to date you have the right to freeze your membership for a **maximum of 1 months per year**. You may do this by filling a membership freezing form.

POOL

Children under the age of 18 will not be permitted to use the pool:

Hygiene

Please ensure that you shower before entering the pool and after using the sauna or the steam room.

Food & Drink

No food is to be consumed in the pool hall at any time. The consumption of non-alcoholic beverages is permitted, but on no account must any glass, metal or ceramic containers be used in the pool and surrounding area.

Floats & Inflatables

No personal floats or inflatables are to be used in the pool.

Saunas

Oils – the use of oils is not permitted in the sauna.

Flammables – flammable or combustible materials should not be left in the sauna IE newspapers, magazines, swimming costumes.

Member & Guest Conduct

A Member (and where appropriate his/her guest) must:

(a) Comply with any applicable dress code for the club.

(b) Show consideration for other Members and their Guests.

(c) Do not use abusive or inappropriate language.

(d) Do not behave in an antisocial or disruptive

Manner including casual activities.

(e) Do not bring/use/be under the influence of

Illegal drugs and/or alcohol in any part of the Leisure Clubs' premises.

(f) Guests must be signed in by a Member immediately upon entering and the appropriate guest fee must be paid.

(g) Guest fees are due in addition to appropriate tariff charges.

(h) Members must be aged 18 years or more before they can sign a Guest into the club.

Termination of Membership

The Manager may terminate the membership of any member/Club user without notice and with immediate effect in the event that a member; Commits a serious breach of the rules as to Members Conduct set out (which may include violence, excessive use of bad language, intimidating/ inappropriate behaviors or behavior in a way which disrupts the enjoyment of the Club by other members)
